The balance at the end of the month in the general operating fund was \$9,599.10.

For the first four months of our fiscal year, the total income received is \$6,457, compared to the budgeted amount for the year of \$22,060. We have spent almost \$9,000 so far this year from the general fund.

Worship and Ministry Committee

Ted Benfey, clerk of Worship and Ministry Committee reported a lack of response to Worship and Ministry's request for members to visit the Winston-Salem Worship Group. Friends are encouraged to sign up and visit. Winston-Salem Friends are also encouraged to ensure representation at our monthly meeting for business and at yearly meeting.

The Committee also urged us all to read Chuck Fager's essay *Survival & Resistance*, which is in the May *Friends Journal*. This will be the subject of forum discussion in late August.

Handbook Committee

The Handbook Committee recommended approval of the following item to be inserted in the next Handbook as an addition to the calendar in the month of July:

The Clerk of the Meeting and the Friendship Meeting Representative to the Yearly Meeting Records Committee will go over all the meeting files to determine what should be sent to the archives and what should be kept in the meetinghouse/discarded.

Friends approve.

The Peace & Social Concerns Committee submitted the following annual report:

**PEACE & SOCIAL CONCERNS COMMITTEE
ANNUAL REPORT, April 9th 2006**

Our year on the Peace and Social Concerns Committee was a balance of acting on particular concerns of members of our committee about ongoing issues, and responding to the unfolding needs in our community and in the larger world.

For example, several of the Forums we hosted in the last year were in response to important topics raised up by members of our committee. Interest in learning more about the changing face of immigrants in our area led to a presentation last June by Raleigh Bailey about how global trends in immigration affect us locally here in the Triad. Also a speaker from the National Farm Worker Ministry will share at our April Forum later this month about the rapid changes in the migrant and farm worker community in North Carolina, and the challenges and opportunities this creates. On a different topic, concern about the ongoing genocide in Darfur, and famine in Niger and other African countries, led us to invite Dr. Victor Archibong from Greensboro College to educate ourselves further about the global forces that are shaping these problems in Africa, as well as what we in the United States might do to encourage positive change.

Individual concerns from members of our committee also guided our disbursements. For instance, this past spring we donated \$100 each to both Ramallah Friends School and Ramallah Friends Meeting in response to interest raised in our discussions.

On the other hand, as always we were mindful of seeking out ways to use our limited resources to respond to crises in a timely manner. For example, after the devastation of Hurricane Katrina, a member of our committee, Judy Reece, received training to be on a Care Team for a family relocated here from New Orleans. In October, she and Carey presented at our October Forum about the structure of the Care Teams and their experiences helping a family settle here in Greensboro.

Similarly, the desire to contribute to recovery efforts here and abroad shaped our remaining disbursements in the last fiscal year. For instance, we donated \$100 to the American Friends Service Committee tsunami relief pro-

gram this past spring. In the fall, we were mindful that many local organizations were facing decreasing contributions because of the outpouring of support for hurricane relief earlier in the year. Therefore, we chose to concentrate locally, donating \$100 to FaithAction, \$100 to Friends Disaster Service, \$100 to the African Services Coalition and \$100 to Greensboro Urban Ministry. In addition, we shared the addresses of other worthy local organizations with the Meeting and encouraged Friends to consider them during their holiday charitable giving.

Another theme of the work of the Peace and Social Concerns Committee this past year was attempting to increase our outreach both within the Meeting and with other organizations. For example, we began a regular feature in the Meeting newsletter that seeks to educate members about a timely issue and provide information about possible steps for concerned Friends to take action. We have also organized collections on behalf of the AFSC Eastern Material Aid Program office in High Point by putting out boxes to gather old stamps and eyeglasses, and more recently, items for farm worker health kits. Finally members of our committee have continued to collaborate with members of New Garden Friends Meeting to organize the North Carolina Repository for Conscientious Objectors. This group has successfully launched a website with information for young people seeking to begin a conscientious objector file, and just recently received its first file all the way from Wilmington! The work of the NCRCO also led to contacts with other concerned people throughout the state, which resulted in a meeting in Chapel Hill to discuss issues such as the draft, Junior ROTC and military recruiting under the No Child Left Behind Act.

We thank the Meeting for its support over the past year, and in particular for the increase in our budget. We look forward to continuing many of these initiatives in the year ahead, while also knowing that we will be called to respond to other needs as they arise.

Richard Phillips on behalf of the House and Grounds Committee presented an urgent matter concerning the excess of impermeable surface on our property. The Meeting is faced with a short deadline for deciding how we want to bring ourselves into compliance with city codes.

Richard Phillips will prepare a summary of the facts for distribution to all members.

After a lengthy and productive threshing session on this matter, Friends approve the appointment of a committee consisting of Richard Phillips, Carey Reece, David Brown, Mary Ellen Chijioke, and George White to study the issue further and develop the most plausible options, with attention to the views presented by Friends today, and bring forward a recommendation or suggested options as quickly as possible.

The Meeting approves this committee employing an engineer and/or an attorney as it deems needed.

The Meeting then adjourned at 3:35 pm after a brief period of silence to meet again on 6th month 11th, if consistent with Divine Will.

Current Issues for Action

Each month, the **Peace and Social Concerns Committee** will highlight an issue of current importance that we would like to bring to the attention of the Meeting. Our hope is that Friends can use this information to educate themselves and take action where they feel led.

Friends Committee on National Legislation is concerned that the pre-war rhetoric and reports about Iraq are now being applied to Iran. For example, there are reports that the Pentagon has started work on detailed planning for air strikes against Iran's known nuclear-related sites. As FCNL points out, the United States is in no position to invade Iran given our troop commitments in Afghanistan and Iraq, but a bombing campaign would be just as destructive -- especially if nuclear targets were bombed, spreading radioactive dust over populated areas.

FCNL asks that concerned Friends contact their senators and representatives, calling on them to speak out against any administrative effort to justify military action against Iran, and vote against any measure that could be construed as an authorization to use military force. Reviving negotiations with Iran, with full and direct U.S. participation, holds the best hope for overcoming differences and meeting the needs of both Iran and the world.

Friends nominated for service on various Meeting committees, as reported on pages 2 and 3 of this newsletter, are expected to begin their service on August 1st.

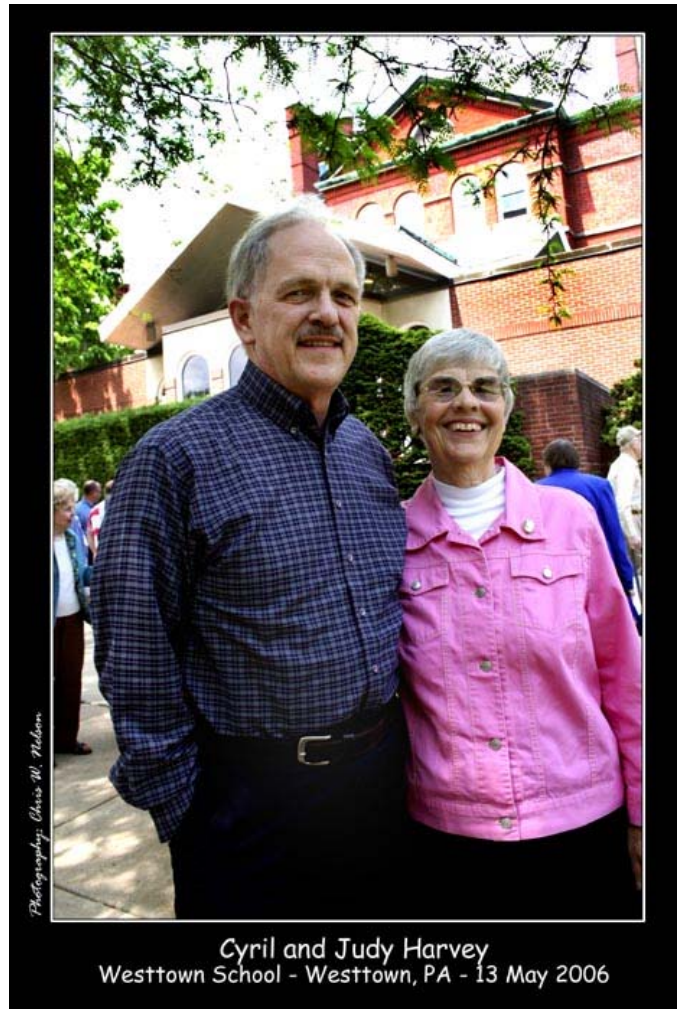
Request from the Handbook Committee

While there is nothing more to report on this matter at the time *Friendship Times* is "going to press," the special committee appointed at monthly meeting has been meeting and will be reporting soon on their deliberations — the facts of the matter, our alternatives, and their recommendations.
