Minutes — Synopsis

FRIENDSHIP FRIENDS MEETING FOR WORSHIP
WITH ATTENTION TO BUSINESS GATHERED ON
THE 14TH OF THIRD MONTH 2010

Friends gathered in waiting worship after a time of food and fellowship.

The third query was read:

Do we follow the teachings of Jesus and seek the inspiration of His Holy Spirit in our daily lives? Are love and unity maintained among us? Do we cultivate a forgiving spirit, and do we avoid and discourage needless and destructive criticism of others? When differences arise, do we endeavor promptly to resolve them in a spirit of love, honesty, and humility?

The following response will be edited by Dave MacInnes:

There are two kinds of queries: one kind becomes part of how you live; the other is one you can answer in words. The first part of this query is the first kind. We cannot answer for the entire meeting as to whether we follow Jesus' teachings; this query is to challenge us daily. Friends maintained a long silence. Obvious differences between friends are easily engaged, and rarely become serious problems. Subtle differences can be more complex since they are easier to overlook. Most don't need to be "resolved" so much as acknowledged. Friends are not aware of anyone regularly exercising needless and harmful criticism. Most of us try to open ourselves to understanding differences. One friend referred to a recent conflict in which one person felt unfairly criticized. Reactions were open and appropriate, and the concern was quickly resolved.

Ray Treadway presented the **Treasurer's Report** for Second Month, which was accepted with gratitude. The complete report is attached; a summary follows.

Expenses of note during the month: sandwiches for Urban Ministry — \$58.76, donation to North Carolina Yearly Meeting Conservative — \$1,500, donation to Piedmont Friends Fellowship — \$350, donation to Quaker House of Fayetteville for operating expenses — \$100, electricity — \$67.79, gas — \$255.76, telephone — \$62.93, and water and sewer — \$9.89. The Meeting received a loan repayment to the emergency assistance fund of \$50. There was one contribution to the building fund of \$100.

Contributions to the Meeting in January and February (\$2,345) are significantly below what is needed (\$3,700) to maintain the Meeting's budget. Contribu-

tions to the general fund and to our special funds would be appreciated. Checks can be made out to Friendship Friends Meeting and sent to POB 8652, Greensboro NC 27419.

Marilyn White reported on behalf of Peace and Social Concerns committee on the five priority recommendations to the Friends Committee for National Legislation. The five priorities were approved.

Gay Bowles reported on behalf of Care and Council committee and brought three concerns to the attention of the meeting.

To the matter of dinner circles, some friends expressed regret at not having been able to participate in the last round of Friendly Eights. A sign up sheet for interested parties, including a few practical questions, will be made available for at least two First Days.

First Sunday, which is normally the day for committee meetings, will fall on the day the world calls "Easter." To allow for conflicting morning celebrations, committee meetings will move to second Sunday, and Meeting for Business will move to 3rd Sunday in April.

The matter of the length of Business Meeting shall be carried over and discussed at the next joint Care and Council / Worship and Ministry meeting. The concern shall be returned to the body of friends thereafter.

A request for membership from Amanda Szabo was received and will be passed on to Care and Council who will suggest names for a clearness committee at the next Business Meeting.

The responses from Nan Bowles's traveling minutes to Davidson Monthly Meeting 2010 and to Scattergood and Earlham in 2007 were read.

Neil Swenson and Hannah Logan Morris were approved to join David Bailey on the Nominating Committee.

Selections were read from the approved minutes of Salem Worship Group.

The revised response to Query #2 was read and approved.

Are we faithful in our attendance at meetings for worship and are we careful not to disturb the spirit of the meeting with our late arrival? Is our behavior therein that of open submission to God in silent communion?

We believe our Meetings for Worship are faithfully attended. We generally quietly absorb late arrivals and this is important to Friends who find themselves arriving late on occasions. Meeting usually starts before the appointed hour, and there are few

disturbances, not only because early arriving Friends are tolerant of late-comers, but also because late arrivals are considerate and careful to enter meeting quietly.

The most important part of worship for some is the silence. That single element sets our manner of worship apart from most others. Our meeting has a tendency to respond to messages given in vocal ministry. Friends practice caution against this, for it can lead to discourse instead of open communion; however, this type of response seldom occurs in our meeting. Much of our vocal ministry speaks to concerns deeply felt by those attending meeting for worship. Though this speaks strongly of our unity in the spirit, this query challenges us to be mindful of the difference between responses that are born of our egos and those that come from the living spirit among us. Several Friends have spoken to the capacity of our meeting to speak directly to each of us in our need, not exclusively through verbal ministry, but also in the immediate sense of the divine moving in the silence. We feel a balance between striving for gospel order and allowing for the mutable requirements of the spirit.

Current Issue for Action

The **Peace and Social Concerns Committee** will often highlight issues of current importance that we would like to bring to the attention of the Meeting. Our hope is that Friends can use this information to educate themselves and take action where they feel led.

We need to support a new START (Strategic Arms Reduction Treaty). The previous START agreement with Russia, which had expired in December 2009, had been a cornerstone of efforts to reduce the buildup of nuclear weapons and helped prevent a U.S.-Russia nuclear arms race. Please ask your senators to support a speedy ratification of START. This treaty is one of the few pieces of legislation that will come before the Senate that has the support of top foreign policy officials from both parties in this country and thus offers the opportunity to make a dent in the partisan atmosphere in Washington. It is more effective to include personal details and explain why you care about this issue.
